SECTION 1: THEORY FOR CLASSROOM DISCUSSION

Q.No.1. Define the term "Audit" and also explain the points that an Auditor has to satisfy himself before expression of opinion?

(A) (NEW SM)

- 1) <u>DEFINITION:</u> An audit is an <u>independent examination</u> of financial information of any entity, <u>whether profit oriented or not</u>, and irrespective or its size or legal form, when such an examination is conducted with a <u>view to expressing an opinion</u> thereon.
- 2) <u>PURPOSE OF AN AUDIT:</u> Audit <u>enhances degree of confidence</u> of users of financial statements as they are verified for its validity and accuracy by an independent competent person.
- 3) POINTS TO BE CONSIDERED: The auditors need to ensure the following during the audit:
 - a) The Information in the financial statements are in conformity with books of accounts.
 - **b)** The journal entries in the books of accounts are <u>supported by sufficient and appropriate</u> (Proper) evidence.
 - c) Ensure that there are <u>no omissions or duplications or fictitious</u> entries in the financial statements.
 - d) The information conveyed by financial statements is clear and unambiguous (without confusion).
 - e) The amounts, classification, presentation and disclosures are as per accounting standards.
 - f) The financial statements are prepared as per applicable financial reporting framework.
 - g) The accounting policies are applied consistently.
 - h) Accounting estimates are reasonable.

4) IMPLICATIONS OF AUDIT OPINION:

- a) The auditor's opinion does not guarantee regarding:
 - i) Future viability of the entity
 - ii) Efficiency and effectiveness of management.
- b) The audit is just an opinion on historical financial information as to whether they are reliable or not.

- To <u>obtain reasonable assurance</u> about whether the financial statements as a whole are <u>free from</u> material misstatements; and
- 2) To report on the financial statements as per relevant SA's based on the auditor's findings.

NOTE: The SA 200 deals with "Overall Objectives of the Independent Auditor and conduct of an audit in accordance with Standards of auditing".

Q.No.3. Write a short note on Scope of Audit?

(B) (NEW SM)

The auditor should consider the following while determining scope of audit:

- 1) <u>COVER ALL ASPECTS OF FINANCIAL STATEMENTS:</u> The audit should cover all aspects of the enterprise relevant to the financial statements.
- 2) <u>RELIABILITY OF SOURCE DATA:</u> The auditor should <u>confirm whether</u> the financial statements are prepared based on a reliable source data i.e., <u>Underlying records</u>.
 - a) The reliability of source data can be verified by <u>evaluation of accounting systems and internal controls</u> and
 - **b)** By performing <u>test checks</u>. (Audit Sampling)
- 3) PRESENTATION AND DISCLOSURE: The auditor shall ensure that the <u>information</u> presented and disclosed in financial statements is as per the <u>relevant statute</u>. This can be done by:
 - **a)** Comparing the <u>financial statements with the underlying</u> accounting records to see that the transactions and events recorded properly:
 - **b)** Considering the <u>judgments</u> (Assumptions and estimates) that management has made to determine their reasonableness.
 - c) Verify the selection and consistency of accounting policies followed.
 - d) Whether the classification, presentation and disclosure of information is appropriate.

- 4) <u>LIMITATION ON SCOPE:</u> If there is a limitation on the auditor's scope then he can <u>report the same</u> in his audit report.
- 5) <u>TECHNICAL DUTIES ARE EXCLUDED</u>: The auditor is <u>not expected to perform</u> duties which fall outside the scope of his competence.

- 1) Audit is restricted to examination of financial statements and books of accounts alone. It has no control over other areas of the entity. Comment.

(B) (NEW SM)

1) EXAMINATION OF INTERNAL CONTROL SYSTEM:

- a) Ascertain whether the <u>accounting and internal control</u> system is <u>commensurate (matching)</u> with the <u>nature and size</u> of business of the entity.
- b) Examine the system to identify the weaknesses that may give an opportunity for fraud or error.

2) AUTHENTICITY AND ARITHMETICAL ACCURACY:

- a) Verify the <u>arithmetical accuracy</u> of the books of accounts by verifying postings, balances, etc.
- b) Verification of validity of transaction entered by scrutinizing books and supporting documents.

3) ACCOUNTING PRINCIPLES:

- a) Verify whether capital and of revenue items are property classified and
- b) Verify whether the incomes and expenses are accounted in proper financial year. (Cut-off)

4) SUBSTANTIVE AUDIT PROCEDURES:

- a) Verify the incomes and expenses recorded in Profit and Loss A/c are true and fair.
- b) Verify the assets and liabilities shown in balance sheet are true and fair.
- c) Verify that the financial statements are in conformity with books of accounts.

5) **STATUTORY COMPLIANCES:**

For corporate entities the auditor has to verify the compliances with various laws and regulations such as Income tax, GST, Companies Act, 2013 and any other applicable laws.

6) REPORTING:

On Completion of audit, the auditor shall express opinion on financial statements in accordance with Standards on Auditing (SA 700).

Q.No.5. Discuss various types of Audits.

(B) (NEW SM)

Audit is <u>not mandatory for all</u> forms of organisations. Depending on requirements of law the audits are classified into two types:

- 1) Statutory audit Audit mandatory under any Law for time being in force.
- 2) Non-Statutory audit Voluntary audit.

1) **STATUTORY AUDIT:**

- a) The organisation which requires compulsory audit under law is known as statutory audit.
 - **E.g.:** Company audit u/s 139 of companies act, 2013. Tax audit u/s 44AB of Income tax Act, 1961, Bank audit under Banking regulation act, 1949 etc.
- b) The <u>auditor shall be independent</u> in case of statutory audits. (Both Mind and Appearance)
- c) The rights and duties of the auditor are determined under the law and terms of engagement.

2) NON - STATUTORY AUDIT / VOLUNTARY AUDIT:

- **a)** The Appointment of auditors even though, is <u>not mandatory under the law</u> is known as Non statutory audit. Also known as VOLUNTARY AUDIT. Eg: Audit of sole proprietary concern, audit of partnership firms.
- **b)** The auditor <u>need not be independent</u> in terms of appearance but the audit process may be carried out independently (Mind).
- c) The <u>rights and duties</u> are determined as per the terms of engagement by the appointing authority.

Q.No.6. What are the advantages of an Independent audit?

(A) (NEW SM, M15 - 5M)

- 1) It <u>safeguards the financial interest</u> of persons who are not associated with the management of the entity, whether they are partners or shareholders, bankers, FIS, Public at large etc.
- 2) It acts as a moral check on the employees from committing frauds or errors.
- 3) For <u>negotiating loans</u> from lenders.
- 4) For determining the <u>purchase consideration</u> for a business in case of amalgamations.
- 5) For detection of weakness in internal controls those are leading to wastages and losses.
- 6) To help in the settlement of accounts at the time of admission or death of partner.
- 7) Government may require audited and certified statement before it gives assistance or issues a license for a particular trade.
- 8) To ascertain whether the necessary books of account and allied records have been properly kept.
- 9) Also helps to settle insurance claims in case of any catastrophe.

- 1) The chief utility of audit lies in reliable financial statements on the basis of which the state of affairs may be easy to understand. Apart from this obvious utility, there are other advantages of audit. Some or all of these are of considerable value even to those enterprises and organisations where audit is not compulsory. Explain. RTP M19 (N&O), MTP N18 (N)

Q.No.7. Write a short note on Inherent Limitations of Audit.

(A) (NEW SM)

The opinion expressed by auditor can <u>only be a reasonable assurance</u>. He <u>cannot obtain absolute assurance</u>. Further the <u>audit risk cannot</u> be reduced to <u>zero</u> but can <u>only be minimized</u> through a proper conduct of audit in accordance with standards on auditing.

Reasonable assurance is a high level of assurance but not absolute assurance.

1) NATURE OF FINANCIAL REPORTING: The financial statements preparation involves many judgements and assumptions which may vary considerably from entity to entity. In addition, many financial statement items involve subjective decisions or assessments or a degree of uncertainty

E.g.: Accounting estimates such as life of assets, provision for doubtful debts, Net realisable value for inventory.

2) NATURE OF AUDIT PROCEDURES:

- a) Further due to legal and practical constraints the auditor could not obtain required evidence.
- b) Normal audit procedures may not be effective to detect frauds which are sophistically carried out.
- c) The nature of audit process is determined by using the auditor's professional judgement.

3) TIME, COST-BENEFIT COMPARISON:

- a) The auditor cannot escape saying time and cost as a reason for not obtaining sufficient appropriate audit evidence even where there is no alternative.
- b) However due to certain external factors the audit shall be completed within a limited period of time. Eg: Legal or regulatory requirements.
- c) Unless the auditor properly plans and perform the audit, the objective cannot be achieved.

4) OTHER LIMITATIONS:

The following are various other events or transactions that cause limitations on audit.

- a) Frauds involving senior management.
- **b)** Entity's ability to be a going concern.
- c) Extent of related party transactions.
- **d)** The occurrence of non-compliance with laws and regulations.

- 1) The matter of difficulty, time, or cost involved is not in itself a valid basis for the auditor to omit an audit procedure for which there is no alternative or to be satisfied with audit evidence that is less than persuasive. Explain. RTP N18 (N), M18(O)

- 2) The process of auditing is such that it suffers from certain limitations which cannot be overcome irrespective of the nature and extent of audit procedures." Explain.

- 3) Distinguish between absolute assurance and reasonable assurance. Identify the type of assurance that is expected in an audit of financial statements, clearly outlining the reasons to justify your point of view.

- 4) Audit procedures used to gather audit evidence may be ineffective for detecting an intentional misstatement that involves, for example, collusion to falsify documentation which may cause the auditor to believe that audit evidence is valid when it is not. Explain

- 5) MNO Ltd requested the auditor CA P to provide for absolute assurance in respect of its ten branches scattered in Delhi and confirm that the financial statements are free from material misstatement due to fraud or error. Advise.
- A. The auditor is not expected to, and cannot, reduce audit risk to zero and cannot therefore obtain absolute assurance that the financial statements are free from material misstatement due to fraud or error. This is because there are inherent limitations of an audit, which result in most of the audit evidence on which the auditor draws conclusions and bases the auditor's opinion being persuasive rather than conclusive.
 - In view of the above, CA P cannot provide audit absolute assurance to MNO Ltd in respect of its branches.
- 6) DEF & Co. Chartered Accountants successfully carried out the audit of Shree Garments for the f.y. 2015-2016. After the completion of the audit, there were found material misstatements due to fraud in the financial statements which were not noticed and reported by the auditor. Management alleges that it is failure on the part of auditor. Comment

Q.No.8. What are the qualities of an ideal auditor?

(C) (NEW SM)

- 1) <u>TECHNICAL QUALITIES: (PROFESSIONAL):</u> The auditor should possess specific knowledge of the following:
 - a) Accountancy Its principles, procedures and standards (AS).
 - b) Auditing Its principles, procedures and standards (SA)
 - c) Direct and Indirect taxation laws such as income tax and GST.
 - d) General principles of law of contracts, partnership;
 - Specific statutes and provisions applicable, E.g. Companies Act, 2013, Banking regulation act, etc.

2) PERSONAL QUALITIES:

- a) Apart from the knowledge acquired by the auditor in aformal manner, the auditor should also possess certain <u>personal qualities</u> such as, tact, caution, firmness, good temper, judgement, patience, clear headedness and common sense, reverbility and trust.
- b) All those qualities that make a good person contribute to make a good auditor.

Q.No.9. Write a short note on Ethical Requirements Relating to an Audit of Financial Statements? (B)(NEW SM)

The auditor shall comply with the relevant ethical requirements as prescribed below:

- 1) <u>INTEGRITY:</u> He should be <u>honest, sincere and straight-forwarded</u> in his approach to the professional work.
- 2) <u>OBJECTIVITY:</u> He should be fair <u>without any bias or prejudice</u>. He should maintain an <u>impartial</u> attitude.
- 3) INDEPENDENCE:
 - **a)** The term independence means that the judgment of auditor should <u>not be</u> made <u>subordinate to the</u> <u>wishes and directions</u> of management or any other person.
 - b) The audit decisions should be taken without giving importance to personal wishes.

- **4)** <u>CONFIDENTIALITY:</u> The auditor <u>should not disclose the information</u> collected by him, during the course of his professional work, to any third party without specific authority from the client, unless there is a legal or regulatory requirement
- 5) PROFESSIONAL COMPETENCE & DUE CARE: The auditor requires specialized skill and competence which are acquired through a combination of general education, training and practical experience.

Q.No.10. "The code of ethics for professional accountants prepared by the international federation of accountants (IFAC) identifies five types of threats." Explain? (C) (NEW SM)

INDEPENDENCE:

- 1) The term independence means that the <u>judgment</u> of auditor <u>should not be made subordinate</u> to the wishes and directions of management or any other person.
- 2) The audit decisions should be taken without giving importance to personal wishes.

THREATS TO INDEPENDENCE: The International Federation of Accountants (IFAC) had identified five types of threats:

- 1) <u>SELF-INTEREST THREATS</u>: Occurs when an auditing firm or any partner benefiting from a <u>financial</u> <u>interest</u> in the audit client.
 - **E.g.:** Shares in the company, loan or guarantee to or from the concerned client, close business relationship with an audit client etc.
- 2) <u>SELF-REVIEW THREATS:</u> Occurs when auditor is <u>reviewing the work which is performed by him</u> during previous assignments.
 - **E.g.:** When an auditor having recently been a director or senior officer of the company, and when auditors perform services that are themselves subject matters of audit like accounting services.
- 3) <u>ADVOCACY THREATS:</u> Occurs when the auditor <u>promotes a client's opinion</u> without a reasonable basis.
 - E.g.: Auditor becomes the client's advocate (representative) in litigation and third party disputes.

- 4) <u>FAMILIARITY THREATS:</u> Occurs when auditor has <u>some association or relation with the clients</u> either directly or indirectly.
 - **E.g.:** Close relative of the auditor working in a senior position in the client company, long association between auditors and client. (Creates Sympathy)
- 5) <u>INTIMIDATION THREATS:</u> Occurs when auditors are <u>prevented from acting</u> objectively / independently. (Blackmailing or Bribing)
 - E.g.: Threat of replacement or pressure to disproportionately reduce work in response to reduced audit fees.

Q.No.11. Write a short note on Professional Skepticism.

(A) (NEW SM)

<u>MEANING:</u> Professional skepticism refers to an <u>attitude of of extensioning mind</u>, being alert to unusual situations and a critical assessment of audit evidence.

Professional skepticism includes being alert to the following situations:

- 1) Conflicts between multiple audit evidences
- 2) Doubts as to reliability of audit evidence.
- 3) Situations of possible fraud.
- 4) Also maintaining professional skepticies throughout the audit is necessary to reduce the risks of:
 - a) Overlooking unusual circumstances.
 - b) Over generalizing while taking decisions from audit observations.
 - c) Taking inappropriate decisions regarding nature, timing, and extent of the audit procedures.

CRITICAL ASSESSMENT OF AUDIT EVIDENCE:

- 1) Is evidence obtained from reliable source
- 2) Is evidence obtained sufficient
- 3) Is evidence obtained appropriate i.e., relevant
- 4) Is there a requirement for an <u>alternative or additional</u> evidence

- 1) The auditor is responsible for maintaining an attitude of professional skepticism throughout the audit. Do you agree with the statement?

<u>MEANING:</u> It refers to taking <u>decisions by the auditor</u> during the course of his audit by using his knowledge, training and experience. Judgment <u>includes assumptions and estimations</u> made by auditor.

Professional judgment is used throughout planning and performing of an audit.

CIRCUMSTANCES WHERE EXERCISING OF PROFESSIONAL JUDGMENT IS REQUIRED:

- 1) Materiality and audit risk.
- 2) Nature, timing and extent of audit procedures.
- 3) Evaluating whether sufficient appropriate audit evidence has been obtained.
- 4) Drawing of conclusions based on the audit evidence obtained.

Q.No.13. Mention any four points which assists the auditor in accepting and continuing of relationship with the client as per SA 220. (A) (NEW SM)

SA 220 "Quality Control for an Audit of Financial Statements" requires the firm to consider the following information before accepting an engagement:

- 1) The integrity of the key management and those charged with governance of the entity;
- 2) Whether the <u>engagement team</u> is competent to perform the audit engagement and has the necessary <u>capabilities</u>, including <u>time and resources</u>;
- 3) Whether the engagement team can comply with relevant effects requirements; and
- 4) Significant matters that have arisen during the previous audit engagement.

Q.No.14. What if there is a Limitation on scope of audit prior to engagement acceptance? (B) (NEW SM)

AS PER SA 210- AGREEING ON TERMS OF AUDIT ENGAGEMENT: Prior to the acceptance of the audit engagement, if there is a limitation imposed by management on the rights and duties of the auditor (Scope), then the auditor shall not accept such audit engagement.

Because with impose of limitations, the auditor <u>cannot obtain sufficient appropriate evidence</u> and hence cannot obtain reasonable assurance results in expression of disclaimer of opinion.

(A) (NEW SM)

The auditor shall <u>obtain a confirmation from the management</u> that they accept and acknowledge their responsibilities relating to financial statements. THE FOLLOWING ARE PRE CONDITIONS TO BE CONFIRMED BEFORE STARTING THE AUDIT:

- 1) Preparation of the financial statements in accordance with the applicable financial reporting framework.
- 2) Designing and implementing necessary internal control to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error; and
- 3) To provide the auditor with:
 - Access to all information such as records, documentation and other matters;
 - b) Additional information that the auditor may request from management for the purpose of the audit; and
 - c) Unrestricted access to persons within the entity from whom the auditor determines it necessary to obtain audit evidence.

- 1) Engagement letter is a document is a document is the auditor to the client, to reduce the chances of misunderstanding regarding scope, objective, rights and duties of the auditor and of management.
- 2) In case of Non statutory audit, the issue of engagement letter is highly recommendatory as there is no governing law regarding rights and duties of an auditor.

1) <u>INITIAL AUDIT ENGAGEMENT:</u> The auditor must issue an engagement letter in case of newly accepted appointment for an audit.

2) RECURRING AUDIT:

- a) If auditor of previous year(s) has also been appointed as auditor for current year, then the current year engagement is known as "Recurring audit".
- **b)** In recurring audits, the auditor shall <u>decide whether there is need to re-issue</u> the engagement letter based on circumstances and <u>depending on professional judgment</u> of auditor.
- c) Circumstances where engagement letter is issued even in case of recurring audits:
 - i) Any indication that the entity misunderstands the objective and scope of the audit.
 - ii) A change in <u>legal or regulatory</u> requirements.
 - iii) A change in the Applicable financial reporting framework.
 - iv) A change in audit reporting requirement.
 - v) A recent change of Top management.
 - vi) A significant change in nature or size of the entity's business.

- 1) <u>REASONS FOR REQUEST MADE BY CLIENTS:</u> A request from the client to change the terms of engagement may result from:
 - a) Change in circumstances.
 - **b)** Misunderstanding of terms originally agreed.
 - c) With a view to restrict the scope of engagement or to alter terms and conditions.
- 2) "ACCEPTANCE OF CHANGE" IN TERMS OF ENGAGEMENT BY AUDITOR:
 - a) If there is a reasonable justification, the auditor can accept the changes to terms of engagement.
 - **b)** Further the auditor and management shall <u>agree and record</u> the new terms of the engagement in a <u>new engagement letter</u>.
- 3) "NON-ACCEPTANCE" OF CHANGE IN TERMS OF ENGAGEMENT BY AUDITOR: The auditor shall not agree for changes in the terms of the audit engagement where there is no reasonable justification for doing so.
- **4)** <u>WITHDRAWAL FROM ENGAGEMENT:</u> If the auditor is unable to agree to a change of the terms of engagement and is <u>not permitted</u> by management <u>to continue</u> the original audit engagement, the auditor shall withdraw from the audit engagement.

As per SA 220 "Quality Control for an Audit of Financial Statements", the engagement partner shall take responsibility for the overall quality on each audit engagement to which that partner is assigned.

The actions of the engagement partner and appropriate messages to the other members of the engagement team, in taking responsibility for the overall quality on each audit engagement, emphasise:

1) THE IMPORTANCE TO AUDIT QUALITY OF:

- a) Performing work that complies with professional standards and regulatory and legal requirements;
- b) Complying with the firm's quality control policies and procedures as applicable;
- c) Issuing auditor's reports that are appropriate in the circumstances; and
- d) The engagement team's ability to raise concerns without fear of reprisals; and
- 2) The fact that quality is essential in performing audit engagements.

(C) (NEW SM)

1) CONCEPT OF INDEPENDENCE:

- a) Independence implies that the judgement of a person is not subordinate to the wishes or direction of another person who might have engaged him.
- **b)** It is <u>not possible to define</u> "independence" precisely.
- c) Independence is a condition of mind as well as personal character.
- d) There are two perspectives of independence of auditors:
 - i) Independence of mind: The state of mind that takes an opinion without being affected by influences of others, allowing such person to act with integrity, objectivity and professional scepticism.
 - ii) Independence in appearance: A person who is a third party to the client (Not related to management and not holding any financial or operating interest) would reasonably be accepted as an auditor. As only a third party will safeguard integrity, objectivity or professional scepticism.
- 2) SAFEGUARDS TO INDEPENDENCE: The Chartered Accountant has a responsibility to remain independent by taking into account the context in which they practice, the threats to independence and the safeguards available to eliminate the threats.

THE FOLLOWING ARE THE GUIDING PRINCIPLES IN THIS REGARD:

- **a)** For the <u>public to have confidence</u> in the quality of audit, it is essential that auditors should always be and <u>appears to be independent</u> of the entities that they are auditing.
- **b)** In the case of audit, the key fundamental principles are integrity, objectivity and professional scepticism, which necessarily require the auditor to be independent.
- c) Before taking on any work, an auditor must consider whether it involves threats to his independence.
- **d)** When such threats exist, the auditor should <u>either withdraw from the task or take certain precautions</u> to eliminate them.
- e) If the auditor <u>is unable to fully implement</u> credible and adequate safeguards, then he <u>must not accept the work.</u>

(C) (NEW SM)

1) AUDITING AND ECONOMICS:

- a) As, it is well known, accounting is concerned with the <u>accumulation and presentation</u> of data relating to <u>economic activity</u>.
- b) The auditors are more concerned with Micro (concerned with the Macro economics.
- c) The knowledge of Macroeconomics stould include the nature of economic force that affect the firm, relationship of price and the role of Government and Government regulations.
- d) Auditor is expected to be familiar with the overall economic environment in which his client is operating.

2) AUDITING AND BEHAVIORAL SCIENCE:

- The discipline of behavioral science is closely linked with the subject of auditing.
- **b)** While it may be said that an auditor <u>deals basically with the figures</u> contained in the financial statements but he shall be required to interact with a lot of people in the organization.
- **c)** As against the financial auditor, the <u>internal auditor</u> is expected to deal with human beings rather than financial figures.
- **d)** One of the <u>basic elements</u> in designing the internal control system is <u>personnel</u>. However, if a sound internal control structure is designed, it cannot work until and unless the people who are working in the organization are competent and honest.
- **e)** The knowledge of human behavior is indeed <u>very essential</u> for an auditor so as to effectively discharge his duties.

3) AUDITING AND STATISTICS & MATHEMATICS:

With the passage of time, test check procedures in auditing have become part of generally accepted auditing procedures.

- a) With the emergence of <u>test check</u> procedure, discipline of <u>statistics</u> has come quite close to auditing as the auditor is also expected to have the knowledge of <u>statistical sampling</u> so as to arrive at meaningful conclusions.
- **b)** The knowledge of mathematics is also required on the part of auditor particularly at the time of verification of inventories.

4) AUDITING AND DATA PROCESSING:

- a) Today, organisations are witnessing revolution in the field of data processing of accounts.
- **b)** Many organisations are carrying out their <u>financial accounting activities</u> with the help of computers which can document, record, collate, allocate and value accounting data and information in very large quantity at very high speed.
- **c)** Dependence on the accuracy of the <u>programmed instructions</u> given today, the computer is able to carry out each of these activities with complete accuracy.
- **d)** With such a phenomenal growth in the field of computer sciences, the auditor should have good knowledge of the components, general capability of the system and the related terms. In fact, <u>EDP auditing</u> in itself is developing as a discipline in itself.

5) AUDITING AND FINANCIAL MANAGEMENT:

- **a)** The auditor is expected to have knowledge about various <u>financial techniques</u> such as working capital management, funds flow, ratio analysis, capital budgeting etc.
- **b)** The knowledge of various <u>institutions and Government activities</u> that influence the operations of the financial market are also required to be understood by an auditor.

6) AUDITING AND PRODUCTION:

- a) While carrying out the audit activity, the auditor is required to evaluate transactions from the accounting aspect in relation to the process through which it has passed through as accounting for <u>by-products</u>; joint <u>products</u> may also require to be done.
- b) The auditor shall also require understanding the <u>cost system</u> in operation in the factory and assessing whether the same is adequate for the particular company.
- c) The understanding of the <u>terminology of the production</u> shall enable an auditor to communicate with production employees in connection with his work.

7) AUDITING AND ACCOUNTING:

- a) It has been pointed out earlier that both accounting and auditing are closely related with each other as auditing reviews the financial statements which are nothing but a result of the overall accounting process.
- b) It naturally calls on the part of the auditor to have a thorough and sound knowledge of generally accepted principles of accounting before he can review the financial statements.

8) AUDITING AND LAW:

- **a)** The relationship between auditing and law is very close one. Auditing involves <u>examination</u> of various transactions <u>from the view point of law</u>, whether or not these have been properly entered into.
- b) It necessitates that an auditor should have a good knowledge of business laws affecting the entity.
- c) He should be familiar with the <u>law of contracts</u>, <u>negotiable instruments</u>, etc. The knowledge of <u>taxation laws</u> is also inevitable as entity is required to prepare their financial statements taking into account various provisions affected by various tax laws.
- **d)** In analysing the impact of various transactions particularly from the accounting aspect, an auditor ought to have a good knowledge about the <u>direct as well as indirect tax laws</u>.

The purpose of monitoring compliance with quality control policies and procedures is to provide an evaluation of:

- 1) Adherence to professional standards and regulatory and legal requirements;
- 2) Whether the quality control system has been appropriately designed and effectively implemented; and
- 3) Whether the firm's quality control policies and procedures have been appropriately applied, so that reports that are issued by the firm or engagement partners are appropriate in the circumstances.

Follow-up by appropriate firm personnel so that necessary modifications are promptly made to the quality control policies and procedures.
